



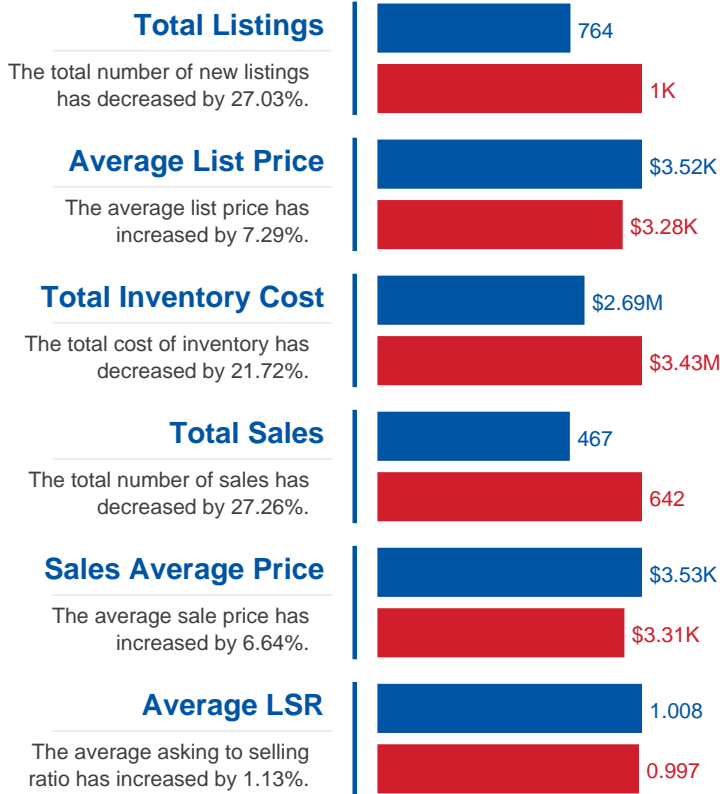

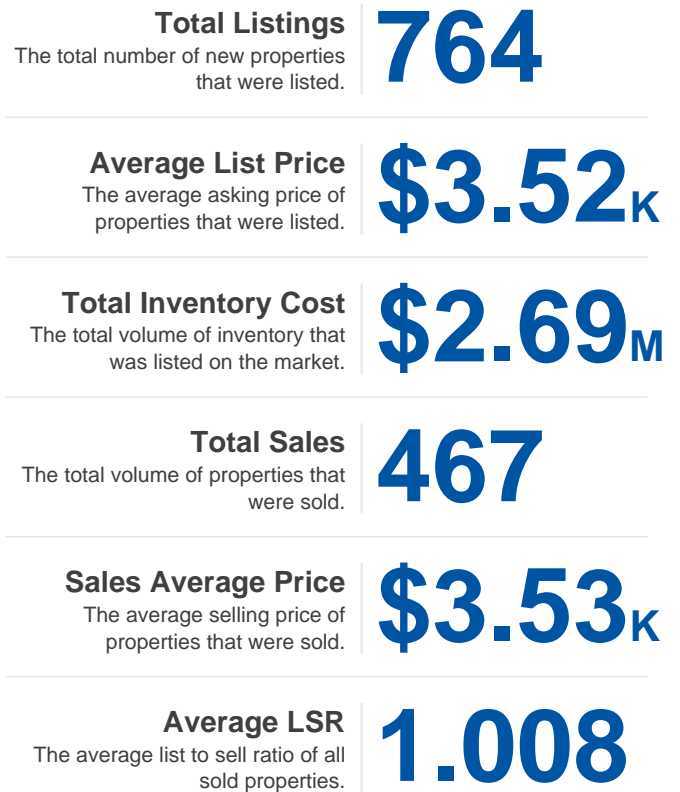
Below, we are comparing the year of 2021 to the year of 2020.

### Average DOM

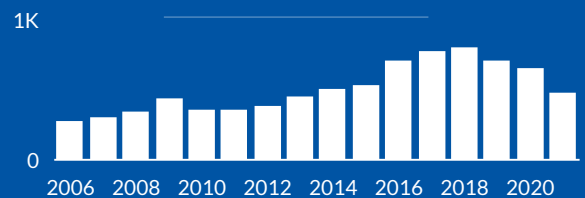

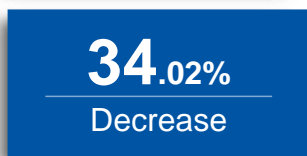

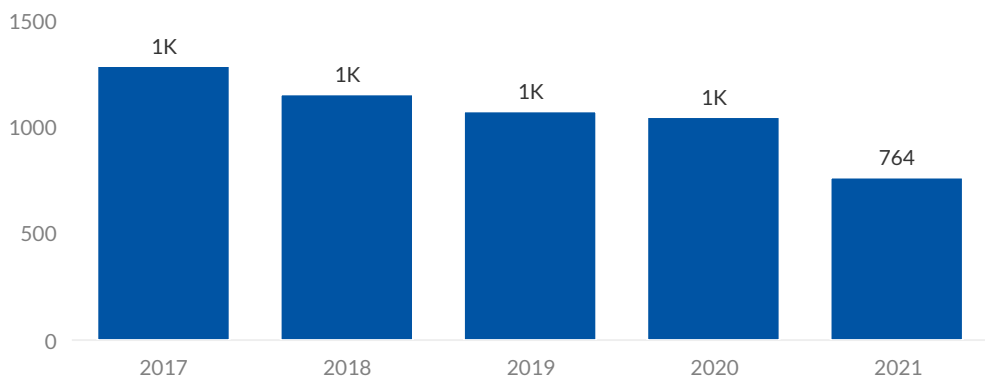

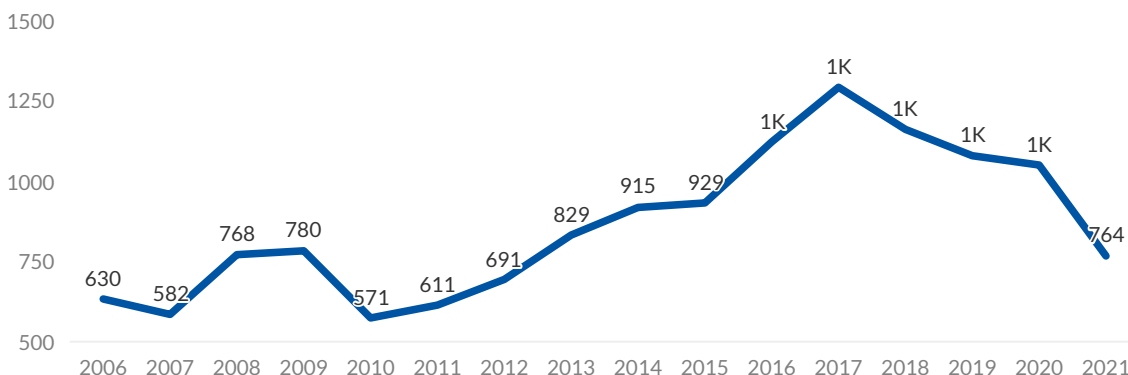

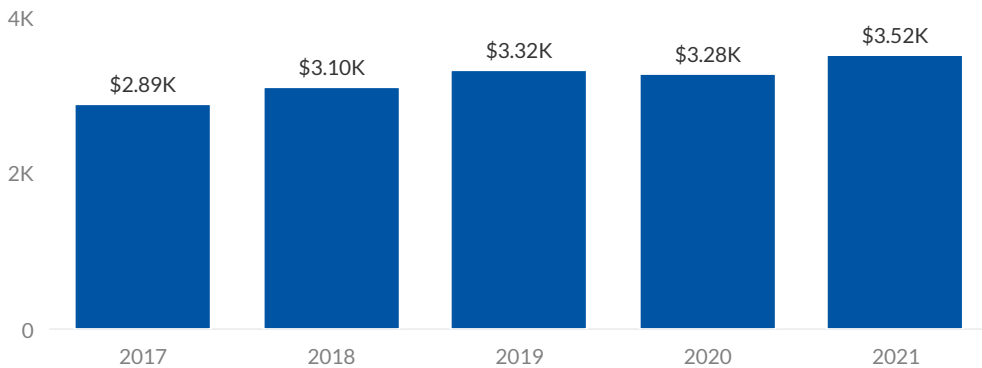

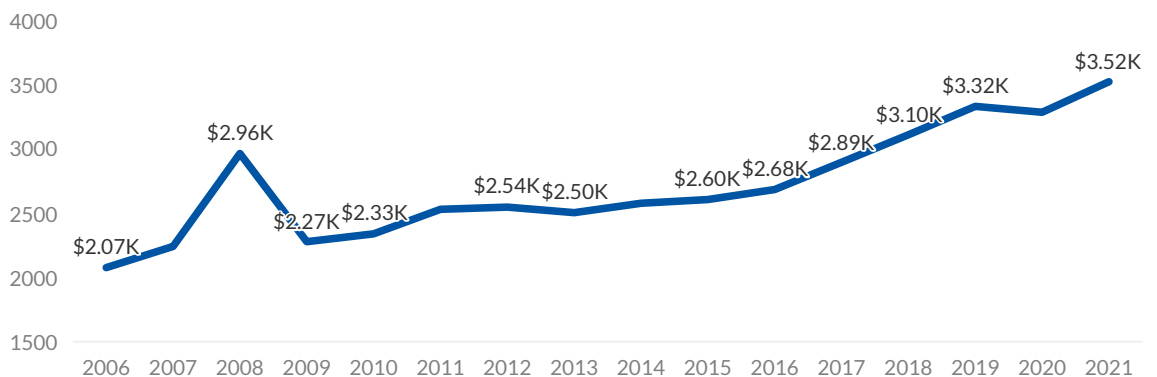

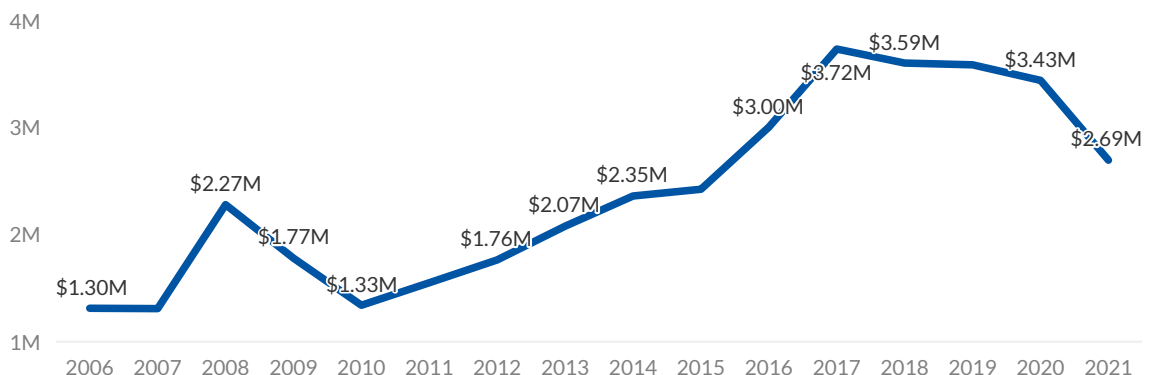

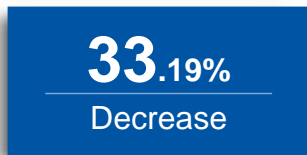

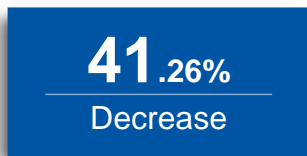

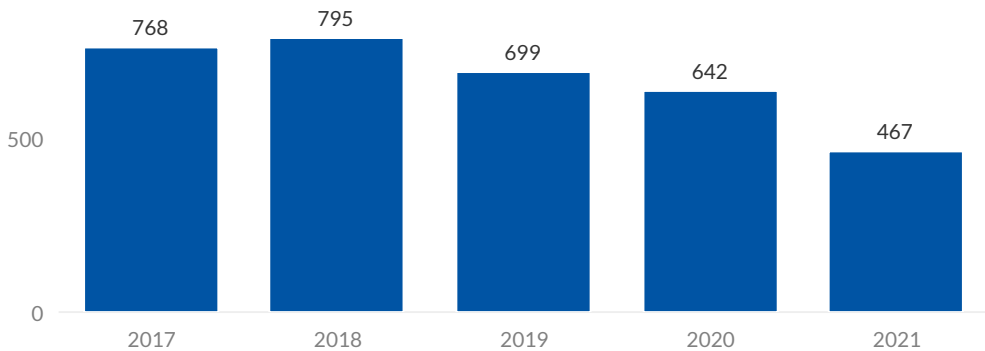

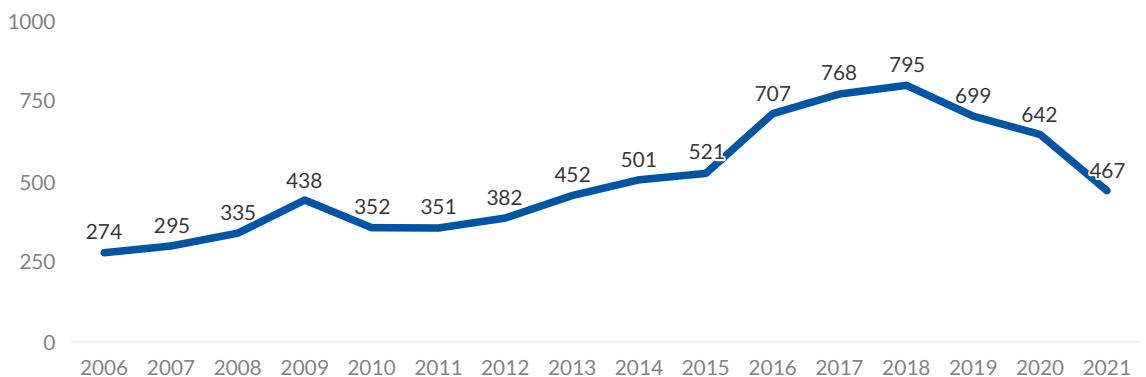

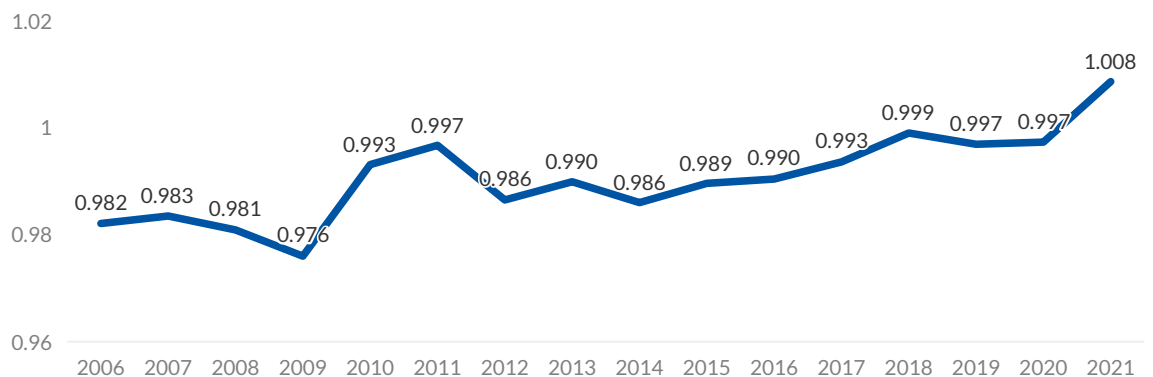
